Position: Sexual Assault Cultural Change Advocate

General Description: This is a temporary position with Oakwood Haven. It will start as soon as possible and end March 31st, 2025. The Cultural Change Advocate will promote Oakwood Haven and its mission. This person's primary focus will be raising awareness of our work and to educate the community about sexual violence.

- Associate's degree in a related field or two (2) years equivalent of education and experience with proven effectiveness.
- Pass a criminal background check.
- Pass a Drug Screening Test.
- Possess a valid Wisconsin Driver's License and automobile insurance.
- Deep familiarity working with various social media platforms.
- Understanding of Trauma Informed Care.
- Excellent computer and technological skills.
- Good understanding and demonstrated skills regarding domestic abuse and sexual assault.
- Outstanding oral and written skills.
- Ability to communicate effectively, problem-solve and work well with people from diverse backgrounds.
- Must be able to work independently with limited direction and meet deadlines.
- Must be able to maintain and handle sensitive confidential material.

- Align Oakwood Haven's message with community needs and Tribal Governing Board strategic plans.
- Maintain a high standard of confidentiality and anonymity.
- Issue education.
- Community engagement.
- Develop and distribute materials on issues related to Sexual Assault and Oakwood Haven Services.

1. **Completed LCO Employment Application, including Release and Authorization form (included in application)**
2. **Cover Letter (Letter of Interest)**
3. **Resume**
4. **At least three (3) letters of Referral (Recommendations)**
5. **And any other supportive documents**
6. **Tribal Member applicants must provide a signed official document from a federally recognized Tribe acknowledging enrollment.**
